We therefore ask you read the code of conduct below so everyone is clear on the expected behavior and understand the consequences for those who choose not to follow the rules.

ADULT CODE OF CONDUCT:

In order to uphold the goals of the Danbury Athletic Youth Organization and it's affiliates and to ensure that all participants have the benefit of a safe and fun learning environment, all parents, guardians and other adults attendees of DAYO events, including but not limited to practices, competitions, and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times.

Any adult who is using alcohol, tobacco or non-prescription drugs and/or appears intoxicated at a DAYO event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, uses social media in a negative way, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee, must receive a verbal warning and/or be asked to leave the event. The member organization may also provide a written warning to the individual regarding the misbehavior. The adult's children may also be removed from the event. Any adult, who commits one of the above stated offenses a second time, will be banned from any and all DAYO events/activities for a period of one year from the date of the second offense, and their children may also be removed from the program(s) for that time period.
